Hire Society Terms and Conditions of Hire

Our terms and conditions are here to help you. At Hire Society we want you to feel comfortable with everything about us and confident that you have all the facts, and that there will be no surprises along the way.

1. Deposit
Bookings are not confirmed until the agreed deposit (usually £75 per car) is paid. This is non refundable.
Balance payments must be made in full two weeks prior to the wedding.
2. Payment
We accept most forms of payment. Cheques to be made payable to "Hire Society" There is no charge for the use of Debit Cards but Credit Cards unfortunately carry a 2% surcharge. Bank transfers can be arranged please ask for details.
3. Cancellations
Cancellation of bookings must be made in writing (not email) and must be signed, the signature being the same of that on the booking form.
Any cancellations made within ten weeks prior to the wedding will be charged at the full rate. Cancellations outside this period will result in loss of deposit. Postponements are deemed as cancellations and will be treated in the same way.
4. Breakdowns
Every possible effort is made to provide a reliable car, but in the unforeseen circumstances that the vehicle breaks down due to mechanical failure, the company accepts no liability, nor responsibility for the consequences of such an occurrence. However, we will endeavor to provide an alternative vehicle. If we are unable to provide a suitable vehicle we will offer a full refund without question. The company recommends that you are covered by independent wedding insurance.
5. Service
The company will make every possible effort to arrive on time at the required locations, however we cannot be held responsible for the late arrival or cancellation due to circumstances beyond our control ie adverse weather conditions , route closures , hold ups or any other whatsoever. The company cannot be held responsible or liable for any impact that a delay or cancellation might cause to other arrangements or bookings made. The company recommends that you are covered by independent wedding insurance.
6. Loss of Belongings
Vehicles are checked at the end of the required period of service, however, Hire Society will not accept any liability for any belongings lost or damaged.
7. Seat belts/Children
Passengers are required to wear seat belts where fitted, and children must be adequately secured in either child seats or Booster seats appropriate to age. These must be fitted by a parent or guardian, our chauffeurs will not be responsible for the fitting of child seats.
